<b>Master OSV LESS Than 1600 GRT/3000 GT Restricted to Service on Liftboats</b>	<b>46 CFR</b>	
720 days of service as mate, chief mate, or master of ocean or near-coastal and/or Great Lakes on self-propelled vessels of more than 100 GRT. 1. Service on inland waters may substitute for up to 360 days of the required service 2. For endorsements restricted to liftboats, service on Liftboats will be credited 1:1 or day for day without regard to whether the liftboat was underway or elevated at the time of service	CG CVC PL 14-03	
<b>Master OSV Greater Than 1600 GRT/3000 GT Or More Restricted to Service on Liftboats (Not To Exceed 10,000GRT/GT)</b>	<b>46 CFR</b>	
720 days of service as mate, chief mate, or master of ocean or near-coastal and/or Great Lakes on self-propelled vessels of more than 100 GRT <b>AND</b> 1. At least 360 days of the required experience must be served as chief mate and be obtained on vessels of 1600 GRT/3000 GT or more or a tonnage limitation may apply (see below).	11.493	
For endorsements restricted to liftboats, service on liftboats will be credited 1:1 or day for day without regard to whether the liftboat was underway or elevated at the time of service.	CG CVC PL 14-03	
<b>A Tonnage Limitation</b> may be issued if 50% of the required service is not on vessels over 1600 GRT/3000 GT; however, <b>ALL</b> required service <b>MUST</b> be on vessels over 100 GRT.	<b>46 CFR</b>	
Limited to max tonnage on which 25% of experience is obtained rounded up to the next 1,000 GRT/GT, <b>OR</b>	11.493	
Limited to 150% tonnage which 50% of service is obtained rounded up to the next 1,000 GRT/GT <b>WHICHEVER IS GREATER</b> . Tonnage limitation on endorsement must not exceed 10,000 GRT/GT.	11.493	

<b>Renewal</b>		
Liftboat service may be used for renewal of any deck officer endorsement and will be credited day for day without regard to whether the liftboat was underway or elevated at the time of service.	CG CVC PL 14-03	
<b>Removal of Restriction to Liftboats</b>		
Liftboat service will be credited 1:1 or day for day when the vessel is underway. Liftboat service while the vessel is elevated will be credited 1:2 (1 day of credited service for 2 days served) for up to 50% of the required service. <i>Note: Service may also be credited as noted here for any deck officer endorsement.</i>	CG CVC PL 14-03

**National Officer Endorsements:** Master (OSV) of Self-Propelled Vessels Not Including Auxiliary Sail of Less Than 1,600 Gross Register Tons (GRT)/3,000 Gross Tons (GT) Upon Near Coastal Waters (Or Upon Oceans -As appropriate) Restricted to Service on Liftboats.

**STCW Endorsement:** Master Restricted to Service on Liftboats. (Limited to Near Coastal Voyages if applicable)

*Note: when the Liftboat restriction is removed, the limitation is replaced with "Limited to service on offshore supply vessels" unless a non-trade restricted endorsement of an equal or higher authority is held.*

**OSV Credential language (More than 1600/3000 GT and Not To Exceed 10,000GRT/GT):**

**National Officer Endorsements:** Master (OSV) of Self-Propelled Vessels Not Including Auxiliary Sail of Less Than X, XXX Gross Register Tons (GRT) / X,XXX Gross Tons (GT) Upon Near Coastal Waters. (Or Upon Oceans -as appropriate) Restricted to Service on Liftboats.

**STCW Endorsement:** Master – Limited to service on offshore supply vessels. Restricted to Service on Liftboats. (Limited to Near Coastal Voyages if applicable)

*Note: when the Liftboat restriction is removed, the limitation is replaced with "Limited to service on offshore supply vessels" unless a non-trade restricted endorsement of an equal or higher authority is held.*

Tonnage will not exceed 10,000 GRT/GT
