## **New Public Portal Website for Suspension & Revocation Proceedings**

The U.S. Coast Guard (USCG) has launched a new Public Portal website for merchant mariners, and their attorneys or other duly authorized representatives, when they are the respondent in suspension & revocation proceedings initiated by the USCG in accordance with the provisions of 33 Code of Federal Regulations (CFR) Part 20 and 46 CFR Part 5. This new capability has been added to the USCG's Marine Information for Safety and Law Enforcement (MISLE) data system as part of the Service's MISLE Enforcement and Adjudication Modernization (MEAM) project.

Merchant mariners who have been served a complaint and have an ongoing case/docket will be able to register at: https://uscg-misle.experience.crmforce.mil/PublicPortal

Attorneys or other duly authorized representatives:

- For cases/dockets initiated after August 29, 2025 they will receive a welcome email with a link to register once their notice of appearance has been filed and accepted by the ALJ/Docket Center.
- For cases/dockets initiated before August 29, 2025, where their notice of appearance has already been filed and accepted they should contact the ALJ Docket Center at <a href="mailto:ALJDocketCenter@uscg.mil">ALJDocketCenter@uscg.mil</a> to request access.

Once registered, users may do the following:

- View the suspension & revocation case details, including the complaint and docket.
- Draft, complete, and file an Answer under 33 CFR 20.308.
- Request an extension to file a response under <u>33 CFR 20.306</u>.
- File additional documents/filings to the docket, including motions, notices, and evidence.
- Initiate a Voluntary Surrender under 46 CFR 5.203.
