## NAVIGATION AND VESSEL INSPECTION CIRCULAR NO. 00-11

Subj: INDEX OF NAVIGATION AND VESSEL INSPECTION CIRCULARS (NVIC)

1. **PURPOSE.** This Circular provides listings of currently applicable NVICs as of January 1, 2011. NVICs are issued by the Coast Guard in the form of printed circulars. Their purpose is to articulate to the public and Coast Guard personnel guidance, requirements or information regarding marine safety rules, regulations and activities.
2. **ACTION.** This Circular is available on the World Wide Web at <http://www.uscg.mil/hq/cg5/nvic/>. The Coast Guard will distribute it by electronic means only.
3. **DIRECTIVES AFFECTED.** NVICs 00-07, 8-73, 2-75, 9-80, 6-82, 11-85, and 4-00 are cancelled. Justification for cancellation of NVICs is listed below.
  - a. NVIC 00-07 is the index of current NVICs as of 1 January, 2007. NVIC 00-11 is the updated index and therefore supersedes and cancels NVIC 00-07.
  - b. NVIC 8-73 is obsolete. The referenced radioactive liquid level meters have not been commercially available or usable for decades.
  - c. NVIC 2-75 is obsolete. The content of this NVIC is superseded by updated inflatable liferaft regulations incorporated in 46 CFR 160.151, Final Rule published May 9, 1997 (62 FR 25525).
  - d. NVIC 9-80 is obsolete. The content of this NVIC was superseded by updated inflatable liferaft regulations incorporated in 46 CFR 160.151, Final Rule published May 9, 1997 (62 FR 25525).
  - e. NVIC 6-82 is obsolete. The content of this NVIC is superseded by updated inflatable liferaft regulations incorporated in 46 CFR 160.151, Final Rule published May 9, 1997 (62 FR 25525).
  - f. NVIC 11-85 is obsolete. The content of this NVIC is superseded by updated regulations for ARPA and Devices to Indicate Speed and Distance incorporated in 33 CFR 164.38 and 33 CFR 164.40 as amended 30 Jun 1998 (63 FR 35532).

g. NVIC 04-00 was superseded by changes implemented in the Consolidation of Merchant Mariner Qualification Credentials Final Rule, 74 Fed. Reg. 11196 (March 16, 2009).

4. BACKGROUND. A Navigation and Vessel Inspection Circular (NVIC) provides detailed guidance about the enforcement or compliance with certain Federal marine safety regulations and Coast Guard marine safety programs. NVICs are used internally by the Coast Guard to ensure that inspections and other regulatory actions conducted by our field personnel are adequate, complete and consistent. Likewise, mariners, the marine industry and the general public use NVICs as means of determining how the Coast Guard will be enforcing certain regulations or conducting various marine safety programs. NVICs are issued by the Assistant Commandant for Marine Safety, Security and Stewardship (CG-5) and address any of a wide variety of subjects, including guidance on vessel construction features; mariner training and licensing requirements; inspection methods and testing techniques; safety and security procedures; requirements for certain Coast Guard regulatory processes; manning requirements; equipment approval methods; and special hazards.

5. DISCUSSION.

- a. Enclosure (1) lists currently applicable NVICs issued prior to January 1, 2011. This list shows the NVIC number, the title of the NVIC and the National Technical Information Service (NTIS) stock number. Enclosure (2) lists those NVICs cancelled during calendar years 2007 through 2010. Enclosure (3) is an alphabetical listing of all currently applicable NVICs. Enclosure (4) contains a partial archival list of NVICs no longer applicable, but useful for reference and historical purposes.

6. PROCEDURES. Current NVICs issued prior to the 00-11 Index are available in paper form for a fee. Orders should be sent to:

- a. NVICs are also posted for public viewing and downloading at no charge on the World Wide Web at: <http://www.uscg.mil/hq/cg5/nvic/>.
- b. The Assistant Commandant for Marine Safety, Security and Stewardship (CG-5) is responsible for administering the NVIC administrative program. Draft NVICs will be provided to CG-5 for number assignment immediately prior to forwarding to signature authority. Additionally, CG-5 is responsible for updating and maintaining the NVIC website.
- c. Once a NVIC has been promulgated, the NVIC will be submitted to NTIS ([input@ntis.gov](mailto:input@ntis.gov)) to be entered into their database and assigned a publication number to be included in the next year's Enclosure (1) of the index.

d. NVICs will be reviewed on an annual basis prior to the publication of the following year's index to ensure the index is accurate and outdated, obsolete, cancelled, or superseded NVICs are removed from enclosures one and three and added to enclosures two and four.

e. Once the index has been signed and published, CG-5 will provide a copy to CG-612 to ensure the Directives, Publications and Reports Index (COMDTNOTE 5600) is up to date.

7. DISCLAIMER. This guidance is not a substitute for applicable legal requirements, nor is it a regulation. It is not intended to, nor does it impose legally-binding requirements on any party. It represents the Coast Guard's current opinion on the topic and is issued for guidance purposes to outline methods of best practice for compliance to the applicable law. You can use an alternative approach if the approach satisfies the requirements of the applicable statutes and regulations. If you wish to discuss alternative approaches (you are not required to do so), you may contact the Assistant Commandant for Marine Safety, Security, and Stewardship, which is responsible for implementing this guidance. The contact number is provided in the questions section below.
