Survival Craft for Commercial Fishing Industry Vessels

January, 2009

Carriage requirements are found in 46 CFR 28.120. The tables show the required survival craft for all vessel types, considering number of individuals on board, and area in which the vessel operates.

Inflatable liferafts: approval series 160.151 & 160.051 A and B



*Servicing requirement: Annually, except for a new liferaft which may defer first servicing until two years from date of first packing.

Required on **Documented vessels**, and **Undocumented** vessels with more than 16 individuals onboard: beyond 50 miles of the coastline (SOLAS A pack); and 20-50 miles of the coastline, *cold* waters (SOLAS B pack).

Inflatable liferafts: approval series 160.051



*Servicing requirement: Annually, except for a new liferaft which may defer first servicing until two years from date of first packing.

Required on Documented vessels, and Undocumented vessels with more than 16 persons onboard: operating 20-50 miles of the coastline, warm waters; and beyond the Boundary Line, 12-20 miles of the coastline, cold waters.

Rigid liferafts: approval series 160.018 and 160.118 (may substituted for 160.051 and 160.151)



*Servicing requirement: Annually inspect and repair as necessary.



A survival craft is not required on a vessel less than 36 feet in length with 3 or fewer individuals on board and which operates within 12 miles of the coastline.

Inflatable buoyant apparatus: approval series 160.010



*Servicing requirement: Annually, except for a new apparatus which may defer first servicing until two years from date of first packing.

Required on **Documented vessels**, and Undocumented vessels with > 16 individuals onboard: beyond the Boundary Line, within 12 miles of the coastline, *cold waters*; > 36 feet in length, inside the Boundary Line, cold waters, or Lakes, bays, sounds, cold waters, or Rivers, *cold waters*; > 36 feet in length, Great Lakes, *cold waters*. Undocumented Vessels with not more than 16 individuals onboard: beyond 20 miles of the coastline; or beyond the Boundary Line, between 12-20 miles of the coastline, cold waters.

Life Float, approval series 160.027



Servicing requirement: Annually inspect, clean, and repair as necessary.

Required on **Documented vessels & Undocumented vessels**: operating beyond the Boundary Line, within 20 miles of the coastline, warm waters.

Buoyant apparatus, approval series 160.010



Servicing requirement: Annually inspect, clean, and repair as necessary.

Required on Documented Vessels & Undocumented Vessels with > 16 individuals onboard: beyond the Boundary Line, within 12 miles of the coastline, *cold waters*, < 36 feet in length; or inside the Boundary Line, any area, or Great Lakes, cold waters, < 36 feet in length; or on Great Lakes > 3 miles of the coastline, warm waters. Undocumented Vessels with not more than 16 individuals onboard: beyond the Boundary Line, within 12 miles of the coastline, cold waters; or inside the Boundary Line, any area, or Great Lakes, cold waters; or on Great Lakes > 3 miles of the coastline, warm waters.

A buoyant apparatus may be substituted for the otherwise required survival craft on a vessel > 36 feet in length with 3 or fewer individuals on board which operates within 12 miles of the coastline.

Equipment required for 160.051 Coastal Service liferafts:

- 1. Rescue quoit and heaving line
- 2. Knife
- 3. Bailer
- 4. Sponge
- 5. Sea anchor
- 6. Paddles
- 7. Whistle
- 8. Flashlight
- 9. Signalling mirror
- 10. Survival instructions
- 11. Instructions for immediate action
- 12. Repair outfit
- 13. Pump or bellows
- 14. Plugs for pressure-relief valves

Differences between 160.051 and 160.151 series Liferafts

Construction and testing requirements for 160.051 life rafts (as compared to 160.151 liferafts):

- 1. Less stringent canopy requirements (may be uninsu lated).
- 2. No viewing port required.
- 3. No Rainwater collection required.
- 4. Carrying capacity may be four persons.
- 5. The floor may be uninsulated.
- 6. The liferaft need be provided with boarding ramps only if the combined cross-section diameter of the buoyancy chambers is greater than 500 mm (19.5 in).
- 7. Less stringent stability requirements.
- 8. The liferaft need not have the manually controlled interior lamp described in Regulation III/39.6.3.
- 9. Less demanding drop test requirement.
- 10.Less demanding loading and seating test require ment (less freeboard allowed).
- 11. Less demanding cold-inflation test requirement.
