RENEWAL REQUESTS RECEIVED UP TO 30 DAYS AFTER THE EXPIRATION DATE OF THE COD WILL BE CONSIDERED 'LATE' AND WILL REQUIRE PAYMENT OF AN ADDITIONAL \$5 LATE FEE. RENEWAL REQUESTS RECEIVED 31 DAYS AFTER THE EXPIRATION DATE OF THE COD WILL REQUIRE REINSTATEMENT.

CODS RENEWED MORE THAN 60 DAYS PRIOR TO EXPIRATION WILL BE ISSUED WITH A NEW ISSUE/EXPIRATION DATE, SHORTENING VALIDITY PERIOD OF DOCUMENT. CODS RENEWED 60 DAYS OR LESS FROM EXPIRATION WILL MAINTAIN THE SAME EXPIRATION MONTH.

ONLINE: via www.uscg.mil/nvdc/ Order Products Online. **CUSTOMERS WHO PAY ONLINE ARE NOT REQUIRED TO SUBMIT A SEPARATE CG-1280.**

BY CREDIT CARD, CHECK OR MONEY ORDER: If paying by credit card, submit completed CG-1280 and CG-7042 AUTHORIZATION FOR CREDIT CARD TRANSACTIONS. IF paying by check or money order, submit completed CG-1280 and check or money order payable to: U.S. COAST GUARD. Annotate number of years on credit card form, or in memo line of check.

COMPLETING THE CG-1280:

1. If the CG-1280 was mailed to you, sign, date and indicate Capacity of Person signing. Enter change of address information, if applicable. PLEASE INDICATE ADDRESS CHANGE BELOW, IF ANY. (A PHYSICAL ADDRESS IS REQUIRED WHEN USING A POST OFFICE BOX.)
2. If you obtained a blank, fillable form from our website, insert name and address in upper left corner of form to the left of the NVDC return address. Enter change of address information below, if applicable. Sign, date, indicate Capacity of Person signing AND enter Vessel Name and Official Number in block titled SEQ #, EXP DATE, VESSEL NAME, O/N.
