Original Requirements	46 CFR & PL 01-17	
1. A Letter of Designation (LOD) dated on or before July 19, 2022 designating the applicant as PIC of a fuel transfer as described in 33 CFR 155.715 and is qualified IAW with 33 CFR 156.120 and 156.150; OR		
2. A letter on company letterhead from the owner, operator, or master of the towing vessel on which the applicant served:		
<ul style="list-style-type: none"> a. Evidence of participation, under the supervision of someone designated as PIC of a fuel transfer, in at least 5 fuel transfers within the preceding five years. b. The name(s) and official numbers of the towing vessel(s). 		
MMC Endorsement/Drafting		
<p>Tankerman PIC - Restricted to Fuel Transfers of Dangerous Liquid (DL) Cargoes on Towing Vessels (**DL Cargo is the default as most LOD's do not have a cargo designated**), OR</p> <p>Tankerman PIC - Restricted to Fuel Transfers of Liquefied Gas (LG) Cargoes on Towing Vessels, AND</p> <p>NEW ** The MMC will <u>NO longer</u> be endorsed with: Ordinary Seaman, Wiper and Stewards Department (FH).</p> <p><u>NO STCW</u> will be issued for this capacity.</p> <p>If any other endorsements IAW 46 CFR 10.109 are requested use the appropriate MMS checklist.</p>		

Renewal Requirements	PL 01-17	✓
1. Application for renewal; and 2. Evidence of 90 days on Towing Vessels within the last 5 years; and 3. Documentation of participation in at least 2 fuel transfers within the last 5 years; and 4. Renewal evaluation and issuance fees (\$50.00 Evaluation and \$45.00 Issue).		
To Remove the Restriction To Fuel Transfer		
All applicants must meet the full requirements of 46 CFR Subpart B or C as applicable to the Tankerman endorsement sought. Fuel transfers may not be equivalent to transfers as required in 46 CFR 13.127.		

Previous guidance directed NMC to issue Ordinary Seaman, Wiper and Stewards Department (FH) even though no valid physical or Medical Certificate. As of September 20, 2018, this will no longer apply. Any applicant requested entry level, follow the entry level MMS.

For those issued entry level previously without a physical or Medical Certificate, to renew the applicant must comply with current renewal standards including medical and chemical testing.
