Refresher Course or Course(s) for all 4 Elements of BT as long as dated within the last 5-years. <p>Note 1. Inspected vessels, MODU's, T/V's and Fish Processing vessels by regulation hold regular drills. May be applicable to other vessels not listed here.</p> <p>Note 2. Table for Calculation of Continuing Competencies

Month/ Year of Original BT Courses	Month/Year 5 years Later	360 days qualifying service met

Note 1. Can only credit qualifying service during the 5-year period, unused service does not carry over to next 5-year period.

Note 2. If applicant does not meet the 360 days qualifying sea service within any 5-year time frame, this option has **not** been met. BT Refresher or original BT courses are required.

Note 3. As long as every 5-year period has the required 360 days qualifying sea service, the current 5-year period need not have 360 total days.
