Endorsement language:

HSC Expiration Date: New HSC endorsements are valid for two years. It will be listed as a limitation after the HSC endorsement: "Not Valid After (Date)." This will be placed on both the national and STCW MMC. See Drafting Manual for individual TRE endorsements.

Additional HSC route(s) being added will have the same expiration date as the route(s) already held.

Exceptional Evaluation and Issuance for Military Sealift Command (MSC) HSC

A Memorandum of Agreement (MOA) between MSC and USCG dated July 2, 2018 allows for the issuance of TRE for MSC Expeditionary Fast transport (EPF) and High-Speed Transit (HST) vessels without a separate expiration date. This is applicable only to HSC with the designation USNS.

- 1. All original issuance MSC TRE's will no longer have a separate expiration date. All other aspects of the original evaluation are the same as all other HSC endorsements.
- 2. For renewal the applicant must provide below items:
 - a. An MSC course completion Revalidation Certificate issued between 24 and 36 months after most recent TRE issuance or last renewal (see note below), and
 - b. A second MSC course completion Revalidation Certificate issued within the 6 months preceding the expiration of the MMC.
- 3. For raise of grade or endorsement with <u>no new</u> 5-year expiration date of the MMC, the expiration date for the MSC HSC TRE endorsement is removed.

Note: If the original or last issued MSC TRE was issued within the previous 2 years of the MMC being renewed, only the MSC course completion Revalidation Certificate issued within the 6 months preceding the expiration of the MMC to renew.

MSC HSC Endorsement language:

[Capacity] Of MSC High Speed Craft Expeditionary Fast Transport (EPF) Class Vessels. Restricted to operation in open waters. {NO EXPIRATION DATE}

Above replaces former endorsement as "Of High Speed Craft Joint High Speed Vessel (JHSV) Spearhead Class restricted to operation in open waters. [2 year expiration date]
