

MARINER CREDENTIALING PROGRAM RAISE IN GRADE VS. MODIFICATION TABLES

Objective & Background:

The document is for use throughout the National Maritime Center (NMC), for the purpose of creating consistency when determining what fees are due and whether an application requires a drug test. **IMPORTANT**, the modification tables provide information to be used when an applicant already holds a credential. The below fee table from 46 CFR 10.219 outlines fees for all endorsements.

The document includes four tables. The tables take into consideration Marine Safety Manual (MSM) Volume III Part A Chapter 1 Figures 1-2 and 1-3, on pages A1-21 and A1-22, while speaking to endorsements that did not exist at the time the MSM table was created.

For fees, refer to Fees Table from 46 CFR 10.219.

For modification of deck officers, refer to the Deck Officer Table.

For modification of engine officers, refer to the **Engine Officer Table**.

For modification of ratings, refer to the <u>Ratings Table</u>.
