

## ATB Determinations for Credit toward Tankerman PIC

Below are listings of Articulated Tug Barges (ATBs) that have been evaluated to determine if their cargo arrangements and equipment are substantially similar to that found on tank ships, and therefore, in accordance with 13.127(c), whether sea service and cargo transfers can be credited toward endorsements as Tankerman-PIC. These lists will be updated as each new determination is made.

For ATBs listed as being acceptable, mariners serving on these ATBs may use the service and cargo transfers to qualify for an endorsement as Tankerman-PIC. Service on these ATBs may be used for any or all of the service on tank ships required in 46 CFR 13.203(a). This service will be credited day for day (1 day of creditable service for each day served). Cargo transfers to or from these ATBs may also be used for any or all of the cargo transfers required by 46 CFR 13.203(b). Service and cargo transfers on these ATBs may also be used for the requirements of 46 CFR 13.120(a)(1) for renewal of a Tankerman-PIC endorsement.

For ATBs listed as being not acceptable, service and cargo transfers cannot be used to qualify for any Tankerman endorsement.

ATB equivalencies are creditable on a case-by-case basis and must have prior authorization by the Coast Guard. Regulatory Reference: 46 CFR 13.127(c) Service on Articulated Tug Barges (ATBs). Service on ATBs with an aggregate tonnage of 1,600 GRT or more will be creditable on a case-by-case basis and with prior authorization by the Coast Guard, provided the ATB equipment is comparable to tank vessel equipment. The Coast Guard may issue blanket authorizations for classes of ATBs.
