Re: Interstate Bridge Replacement Project Mitigation Agreement

Dear Ladies and Gentlemen:

Greenberry Industrial, LLC ("Greenberry") provides this letter pursuant to Section 2.1.3 of the referenced Agreement to Mitigate Impacts to Navigation Relating to the Interstate Bridge Project with an Effective Date of October 16, 2025 (the "Mitigation Agreement"). Pursuant to this section of the Mitigation Agreement, Greenberry is to provide a high-level summary of its efforts to utilize the Mitigation Payment (as defined in the Mitigation Agreement) in order to maintain some level of operations in Oregon and Washington.

In anticipation of receipt of the Mitigation Payment, Greenberry is identifying and evaluating opportunities to grow its operations in Oregon and Washington via capital investments, employee training programs, business acquisitions, additional shop locations and/or expansion or retrofitting of existing locations in the two states.

We trust that the foregoing demonstrates our commitment to maintaining operations in Oregon and Washington, despite the impacts caused by the reduced VCN of the Proposed Bridge Design. We will continue with these efforts in the months and years ahead and provide periodic updates to this group.
